## I. PROGRAMME IMPLEMENTATION

### I.1. HORIZONTAL PRIORITIES AND ACTIONS

#### I.1.1. Inclusion and diversity

The PTNA focused its work on achieving the objectives approved in the WP 2023 to make the programmes more inclusive for organisations and young people in Portugal. Throughout the year, we carried out several dissemination and promotion actions in our communication networks about the actions of the programmes and the Agency in the field of I&D. We promoted training activities, seminars and study visits in the framework of TCA/NET in the field of I&D in order to improve the quality of projects in the programme actions (KA2, KA1, ESC) as well as the involvement of new beneficiaries. We have maintained the dissemination of activities from the NA network to different under-represented target groups in the programme in PT, such as disability, LGBTI+ and mental health. We are reaching out to new organisations and focusing on improving the quality of projects and the work of youth workers. We maintained the increased preparation and monitoring of participants selected for TCA/NET activities in the context of inclusion. This monitoring was carried out by the ID Officer and colleagues from the NA. The NA actively participated in long-term partnerships with other NAs and with Salto I&D. We continued our work in SPI-NEET and fulfilled the purpose of this partnership. As part of the Mental Health SNAC, we hosted an international activity to discuss mental health in the context of youth and how to improve work in this area. Networking was maintained with relevant PT institutions working with YPWFO and special needs such as CAIS; ACM; CASES and others. The situation in Ukraine continued to guide our I&D activities and concrete initiatives were implemented. We created an Inclusion Library, which will be available in our networks in the future, bringing together relevant information and existing resources in a single place, with information in Portuguese to guide the use of resources, and whose target audience is all actors working or wanting to work with ID.

Overall, YPWFO participation has increased globally. We have increased investment in under-represented and sparsely populated areas. In terms of geography, in order to achieve a more balanced implementation of the programme and to attract newcomers to the different actions of the programmes, the NA has maintained its policy of prioritising projects in rural and outermost regions. We are continuing to work with communities and authorities in rural and outermost areas to attract new beneficiaries, diversify and improve the projects of organisations and young people in these areas. Areas where we are still working and have not fully materialised: The mapping of inclusion organisations has been reassessed and its implementation is expected in 2024, in conjunction with other mappings required as part of our participation in the Ray network; the internal audit of NA's methodologies and processes in relation to inclusion is ongoing and should be completed in 2024.

We implemented in 2023 the strategy defined in the multiannual plan.

At international level, developed and deepen several synergies in the youth field, namely

- Initiatives organised within the framework of the Council of Europe's youth policy;

- Cooperation with the Portuguese Government and the Portuguese Institute for Youth and Sport in the development of the National Youth Plan;

- Cooperation with the associations of youth workers and the Portuguese representative organisation of young people in the development of the profession and its recognition;

- Cooperation with municipalities on relevant youth policies;

- Deepening relations with the EU Representation in Portugal, namely with joined actions;

- Cooperation with the European Parliament, organising joint activities;

- Cooperation with beneficiaries with large innovative projects concerning other European funding programmes such as centralised actions, cohesion funds, Creative Europe Programme, Youth Guarantee Programme, ENIC/NARIC and EURES or other funds from other Directorates-General.

At national level, relevant projects that can be funded in the field of employment, youth associations or social innovation were identified and forwarded to, among others, the Employment Services, Social Security, Portugal Social Innovation, CASES (with responsibility for volunteering), ACM (for the integration of migrants) and CAIS (for inclusion).

Concrete actions:

- Publication on the NA website of relevant calls and opportunities related to the Council of Europe/EU partnership;

- Participation in Council of Europe conferences on youth policy;

- Participation in the working group for the development of the National Youth Plan; - Participation in the national working group for youth dialogue in the EU;

- Regular contacts with municipalities in the framework of long-term European partnerships to develop international mobility of young people and youth organisations;

- Direct promotion of European opportunities with national employment agencies;

- Involvement of the EU Representation in Portugal in the promotion of the programmes;

- Regular meetings with entities related to the promotion of entrepreneurship and youth inclusion, in order to promote synergies in working with young people and youth organisations;

- Cooperation with the National Erasmus+ Offices of the neighbouring countries, especially the Ukrainian one, to deepen the cooperation within Erasmus+ and the European Solidarity Corps.

- Visit to Ukraine to promote cooperation

- Webinar "Erasmus+ Future Focused for Youth Ukraine" to reinforce the collaboration with the National Erasmus+ Office - Ukraine to empower Ukrainian and European Youth Actors with renovated partnerships towards the Erasmus+ cooperation.

The great achievement in the area of Communication in 2023 was again the roadshow that toured all regions of the country from north to south, with 25 stops and with 8 531 visitors and other stakeholders contacted.

Other important initiative was "AgoraEU", with the most important stakeholders of the programmes, that count on more than 1.707 PAX. and was organised together with a National Conference on Youth Participation promoted by the Portuguese Republic Presidency.

Pre-departure meeting Porto, 3/06/2023 The event that took place on an emblematic spot of Porto, "Palácio da Bolsa", was a moment of training , sharing and learning, with the participation of hundreds of discoverEU participants, from all over the national territory, who benefited from this action in 2022 and 2023, but also a cultural moment. The opening featured a moment of music and dance and the closing featured a Dj Set.

The NA organised a team of 12 elements from the pool of trainers who develop the training and organized the sharing moments and the interaction between participants.

The programme was mainly aimed at preparing the participants for their travels, reflecting on the expectations of young people and sharing ideas and tips. More than 600 young people signed up for this initiative. The participants were divided in 6 different groups and supported by two trainers in each one of the groups.

## Infokit

The NA developed an info-kit on the action and sent to the participants before the pre-departure meeting. During the event the participants had the opportunity to clarify all the questions related with the initiative.

## Meet-ups

The National agency in cooperation with the Eurodesk network organized and disseminate information of 4 meet-ups spread form the country. The meet-up offered a programme, lodging and meals during for the participants and support of the local organisers. The adherence to meet-ups was not as expected and there were no participants attending them. The geographical localization and the train lines to Portugal does not favour the travels for our country.

Meetings with stakeholder

During the AgoraEU initiative, the NA agency had a session dedicated to DiscoverEU.

Special highlight to the meeting with young people during this event. As former DiscoverEU participants, it was also an opportunity to train them as programme ambassadors, recognizing and motivating them to be the main disseminators of the initiative. At the moment they are in fact a group of DiscoverEU ambassadors and work with organizations, carry out activities in schools and participate in other actions of the program. This work is also carried out in cooperation with the Eurodesk network.

Training and evaluation cycle (European Solidarity Corps) - assessment of implementation:

The ESC Training Cycle activities were organised in full compliance with the provisions of the Guide for NAs.

The PT NA carried out face-to-face trainings, 12 ON Arrival sessions, 7 Mid Term, 1 Annual Event and 1 ESC Quality Label Event for organisations, covering all the needs of participants and organisations in 2023.

The training strategy was designed with 3 central objectives:

1 – Respond to the training needs for young participants, national and international, within the scope of ESC with modernity, agility and efficiency.

2 – Respond to training needs, fostering a strategy of complementarity in action, training, knowledge and good practices that are useful and relevant to the various audiences.

3 – Allow access to produced knowledge, good practices and training processes to other organizations and young people, in addition to the participants in the programmes, namely in the area of volunteering in Portugal.

The training process had 3 fundamental characteristics:

1 – Holistic: that, fulfilling the formal requirements, it is designed and carried out to meet the needs of each public, in a process as broad and continuous as possible, and that does not end with the training moments,

extending and enhancing its impact with the possibility of self-training, complementary moments of participation and spaces for knowledge and sharing of good practices.

2 – Hybrid: allowing participation in face-to-face training moments, online training moments – synchronous and asynchronous – and moments that combine these two complementary formats.

3 – Modular: built on a modular basis that allows a coherent and shareable organization, while allowing an easy understanding and access to the contents, fulfilling the objectives at all times.

The training was based on the construction of a modular content organization matrix, transversal to the entire AN internal training process.

For training, the NA resorted to its pool of trainers who have the appropriate skills and preferentially use nonformal education methods and address the actions in their various pedagogical, cultural and social dimensions.

Considering the number of actions, the methods and format of the actions, NA evaluates the implementation of the Training and Evaluation Cycle as very positive.

The annual event targeting to ex-volunteers that completed their project on the last 12 months as an opportunity to share their experiences, the learning outcomes during the project where the volunteers were involved.

The annual event for organisation with Quality Label created a space to improve the capacity of the organisation to develop ESC projects. It was also an important moment to share experiences between organisations, as well to provide specific training to the newcomers.

In KA1 the number of applications increased from 385 in 2022 to 461 (including 33 Accredited projects for youth mobility) in 2023.

The average score of projects approved under KA1 was 78,6 points, compared to 75,8 points, in 2022.



Nevertheless, only 31% of applications were approved, due to the lack of funds available to support all the quality projects submitted to the PT02NA.

However, we would like to stress that 409 (89%) submitted applications had the required quality to be approved out of the total of 461.

In KA1 the number of projects approved were: 58 Youth Exchanges, 24 Youth Workers Mobilities and 24 Youth Participation activities.

Analysing the objectives, priorities and topics addressed in the applications, we can notice that, in submitted applications - Youth Exchanges, Environment and climate change was

the leading topic, addressed in 33,7% of the applications. Green skills ranks second, representing 23,4% of the applications. Inclusion of marginalised young people come in third place, being addressed in 18,8% of the proposals submitted.

Regarding Youth Workers Mobility, in first place Quality and innovation of youth work, addressed in 47,9% of the submitted projects. In second place, Inclusion of marginalised young people, representing 20,2% of the submitted applications. Key competences development and New learning and teaching methods and approaches come in third place, being addressed in 17,6%.

In submitted applications - Youth Participation activities, Democracy and inclusive democratic participation was the leading topic, addressed in 60,5% of the applications. Promotion of alternative forms of participation ranks second, representing 37,2% of the applications. Reaching the policy level/dialogue with decision makers, come in third place, being addressed in 32,6%.

Regarding the amount allocated to projects involving partner countries, 22,4% of the approved budget was allocated to Youth Exchange and 26,1% to Youth Workers Mobilities.

The distribution of projects and the geographic distribution of participants (interior of the country, coastal area/seaside and urban centres) is presented in the tables below:

## Key Action 2 - Cooperation partnerships and small-scale partnerships in youth (KA210-YOU; KA220-YOU)

In KA2 the number of applications increased from 126 in 2022 to 220 in 2023.

The average score of projects approved in KA2 was 73,6 points, comparing to 74,7 points in 2022. The average score of the submitted applications in KA2 was 64,7 points, comparing to 65,9 points in 2022. Regarding 2023, 16,2% of applications were approved, due to the lack of funds available to support all the quality projects submitted to the PT02NA. 62 submitted applications in 2023 had the required quality to be approved

out of the total of 99.

In KA2 the number of projects approved were: 7 Small-scale Partnerships and 9 Cooperation Partnerships. Analysing the objectives, priorities and topics addressed in the applications, we can notice that, in submitted applications KA2 - Small-scale Partnerships, Quality and innovation of youth work were the leading topic, addressed in 25,8% of the applications. Inclusion, promoting equality and non-discrimination ranks second, representing 22,6% of the applications. Digital skills and competences come in third place, being addressed in



## 16,9% of the proposals submitted.

Regarding KA2-Cooperation Partnerships, in first place Green skills addressed in 21,6% of the submitted projects. In second place, Entrepreneurial learning - entrepreneurship education, representing 20,6% of the submitted applications. Quality and innovation of youth work come in third place, being addressed in 18,6%.

The geographic distribution of awarded projects (interior of the country, coastal area/seaside and urban centres) is presented in the table below,

Approved Projects Region - % Urban Centers – 50,0 Coastal area/seaside – 37,5 Interior – 12,5

We can notice an interesting diversity in the type of organizations that apply, such as Non-governmental organisation/association, Youth organisation and Small and medium sized enterprise.

## I.3.3. Erasmus+ Sport

## Key Action 1 - Mobility of sport coaches and staff in the field of Sport (KA182)

In Sport the number of applications was 36 in 2023.

The average score of projects approved under Sport was 69,8 points, in 2023.

In this new action, 69% of applications were approved.

We would like to stress that 33 (92%) submitted applications had the required quality to be approved out of the total of 36.

Analysing the objectives, priorities and topics addressed in the applications, we can notice that, in submitted applications, Initial and continuous training for sport staff was the leading topic, addressed in 66,7% of the applications. Inter-regional cooperation and Preventing early school leaving and failure in Education ranks second, representing 44,4% of the applications. Supporting grassroots sport come in third place, being addressed in 25,0% of the proposals submitted.

## I.3.4. European Solidarity Corps

In Volunteering projects the number of applications increased from 72 in 2022 to 81 in 2023. Regarding Volunteering projects, 72 applications were approved, representing a success rate of 88.9%. Analysing the priorities in the applications, we can notice that, in submitted applications, Inclusion and diversity was the leading topic in Volunteering projects, addressed in 88,9% of the applications. Environmental protection, sustainable development and climate action ranks second, representing 71,6% of the applications. EU youth goals come in third place in the applications, being addressed in 70,4% of the proposals submitted.



The geographic distribution of awarded projects (interior of the country, coastal area/seaside and urban centres) is presented in the table below, Approved Projects Region - % Urban Centers – 46 Coastal area/seaside – 40 Interior – 14

Regarding the Quality Label, despite being in the third year of the Program, the numbers obtained in 2023 are quite satisfactory, with 34 organizations that have received the European Solidarity Corps Quality Label, above the NA forecast, 30. These results reveal that the The work organized by NA is having an effect and we continue to have many entities that intend to participate in this action, Volunteering.

## Solidarity projects - ESC30

In Solidarity projects the number of applications increased from 77 in 2022 to 129 in 2023.

The average score of projects approved in Solidarity projects was 75,8 points, comparing to 71,3 points in 2022. The average score of the submitted applications in Solidarity projects was 70,5 points, comparing to 69,0 points in 2022.

Regarding Solidarity projects, 50 applications were approved, representing a success rate of 38,8%. Analysing the objectives, priorities and topics addressed in the applications and in the granted projects, we can notice that, in submitted applications, Community development was the leading topic in Solidarity projects, addressed in 40,3% of the applications. Bridging intercultural, intergenerational and social divide ranks second, representing 28,7% of the applications. and Creativity, arts and culture come in third place in the applications, being addressed in 25,6% of the proposals submitted.

The geographic distribution of awarded projects (interior of the country, coastal area/seaside and urban centres) is presented in the table below,

Approved Projects Region - % Urban Centers - 48 Coastal area/seaside - 30 Interior - 22 Participants Region - % Urban Centers - 48 Coastal area/ seaside - 31 Interior - 21 We can notice an interesting diversity in the type of organizations that apply, such as Non-governmental organisation/association, Youth organisation and Group of young people in the youth field.

The management of the programme has proceeded normally with the fulfilment of the delegation agreements and with all the reports reaching the minimum quality threshold for acceptance without grant reduction. The programme is perfectly consolidated in Portugal, has a stable, informed and interested public as target audience, with a special emphasis on youth organizations, and has a series of national and international strategic organizational partnerships Achievements of 2023:

- presence of National Agency on several long term partnerships levelling the knowledge and needs analyses of the programme;

total support of the Portuguese National authorities, given a clear legal framework and mandate to the NA;
 maintenance and motivation of the work team and rapid adaptation to the implementation requirements of the programme;

- smooth transition to the new rules, actions and procedures of the new programme;

- more than enough quality applications to absorb programme funds;

- young people's interest in the programmes' actions;

- significant incorporation of the priorities established by the new programmes and visible on the applications; The feedback from beneficiaries has been very positive in several aspects:

- understanding and adapting the priorities, new actions, IT tools and new accreditation schemes;
- adherence to the National Agency's information and training actions;
- presentation of a large number of proposals for the various actions of the programme;

- boost of the visibility of the programme with several appearances on National news;

In general terms, the feedback from organizations and participants, received in the actions organized by the NA and received in the projects execution's reports, has been very positive and the potential and benefits of the programme for young people and organizations have been highlighted by them.

Regarding the amount allocated to projects involving partner countries, 24,0% of the approved budget was allocated to KA151, 22,4% to KA152 and 26,1% to KA153.

In relation to KA2, were finalized 7 KA205; 2 KA227; 8 KA210-YOU and 1 KA220-YOU. The final scores were satisfactory, with values between 66 and 80 points. Of the completed projects, 3 were considered Good Practice. In general, the objectives of the completed projects were met satisfactorily, as evidenced by the aforementioned classifications.

#### I.4.3. European Solidarity Corps

With regard to the development of programme actions: - there was a smooth transition to the new rules associated with Quality Label;



- the NA managed to implement the funds with efficiency, transparency and fairness to the applicant organizations;

- the NA managed to boost the execution of Solidarity Projects, increasing the number of applications submitted and supporting more projects than in previous years;

- fulfilment of the delegation agreements;

- The percentage of final reports reaching the minimum quality threshold for acceptance without grant reduction, was actually 100%

- The number of registrations of Portuguese young people on the ESC Portal continues to be one of the biggest in Europe – 13.356;

- Candidates were able to incorporate the programme priorities in their Projects;

The feedback from organizations and participants was very positive. In the actions of the Training and Evaluation Cycle and in the face-to-face activities already described, as well as in the monitoring and checks activities, it was possible to verify:

- that there is in fact an increase in the Quality of the Projects;

- that the conditions of volunteers in the Projects are adequate;

that the solidarity and learning components in the Projects have a harmonious and complementary presence;
 that the process of simplifying the financing schemes pleases the organizations and allows them to carry out the Projects in a more flexible, efficient and quality way.

Since 2021, the percentage of the budget for in-country activities was 4.6%.



## II. PROGRAMME MANAGEMENT

## **II.1. BUDGET MANAGEMENT**

#### II.1.1. Fund management

#### a) Commitment level for Call year 2023

#### Erasmus+ (please provide an analysis per programme field)

The commitment rate for 2023 is 63.1% per field. The reason for this level of commitment is that the projects of the 2nd round were not taken into account for the following reasons: for KA1, although the selection committee took place on 21 December, the results of the grant award were not communicated until the beginning of 2024, after the hearing of the interested parties had taken place in accordance with national law; for KA2, the selection committee took place on 25 January 2024, as foreseen in the Calendar of Funds. If all grant agreements are issued and signed in early 2024, as foreseen in the calendar of funds, the commitment rate will be 102.8%.

## European Solidarity Corps

The commitment rate for 2023 is 83%. The reason for this level of commitment is that the 2nd round projects are not taken into account because, although the selection committee took place on 21 December, the results of the award of grants were not communicated until the beginning of 2024, after the hearing of interested parties had taken place in accordance with national law. If all grant agreements are issued and signed at the beginning of 2024, as foreseen in the calendar of funds, the commitment rate will be 100.7%.

## b) Realisation level for 2019 and 2020

## Erasmus+ (please provide an analysis per programme field)

The budget realisation rate for 2019 is 93.35% per field, which is above 90%. The budget realisation rate for 2020 is 89% per field, slightly below 90%. However, the 2020 DA is not yet closed and will be closed by 30/06/2024 according to the Fund's calendar, so the realisation rate may be higher. Although our expectation was to achieve a 100% of realisation rate and despite all our efforts, this rate is the result of frequent and common changes in the projects (e.g. changes in the number of participants, real costs, etc.) and 6 cancelled KA1 projects and 1 cancelled KA3 project.

## European Solidarity Corps



The budget realisation rate for 2019 is 91.5% per field, which is above 90%. The budget realisation rate for 2020 is 88.15%, slightly below 90%. However, the 2020 DA is not yet closed, it will be closed by 30/06/2024 according to the calendar of funds, so the realisation rate could be even higher. Although our expectations were to achieve a 100% of realisation rate, and despite all our efforts, this rate is the result of frequent and common changes in the projects (e.g. changes in the number of participants, real costs, etc.). These changes result not only in non-execution of the approved budget but also in recoveries. There is also 1 cancelled project in the field of traineeships and jobs. The committed budget in ESC41 - Training and Evaluation Cycle was not fully used as we managed the budget efficiently which resulted in lower costs.

## II.1.2. Allocation policy

The PT National Agency made some budget transfers in 2023 in accordance with the Contribution Agreement, such as

- In the Erasmus + Programme, funds allocated to KA2 Cooperation Partnerships and TCA - Training and Cooperation Activities, which are not expected to be implemented, were transferred to KA2 Small Partnerships and KA1 Mobility Projects in the field of Youth and Youth Participation Activities;

- In the European Solidarity Corps, funds allocated to the Training and Evaluation Cycle, which are not expected to be implemented, have been transferred to Voluntary Activities and Solidarity Projects.

The budget transfers were made in order to maximise the implementation of the programmes, to respond positively to the needs and expectations of our stakeholders and in accordance with the Contribution Agreement.

As far as Erasmus+ Sport is concerned, and according to the approved WP 2023, the PT NA only distributed the funds for one round. We pointed out in the WP that, if necessary, since this was a new action, we would ask the Commission to open a second round. It was indeed necessary, and in order not to disappoint the expectations of potential candidates and to use the available budget, we had a second round. R1 was 41% and R2 was 59%. According to the approved WP 2023, PT NA distributed the funds for ESC in 2 rounds. In the solidarity projects, the realised was 42% in R1 and 58% in R2. We have assumed the difference between the approved and the implemented. The reasons for this are the number of applications submitted, the number of projects approved in relation to their allocated budget, combined with an optimisation of the implementation of the funds for the action, including the implementation of the remaining budget from the optional round. For Volunteering, the implementation rate was 86% for R1 and 14% for R2. We expected a slight deviation between the approved and the implemented. The reasons for this are the number of applications submitted, the number of new applicants and newly accredited organisations after the first round, which could only apply for one round per year, combined with the optimisation of the implementation of funds for the action. This distribution meets the expectations of the organisations and is more responsive to the needs of the applicants. For accredited organisations, the achievement was 50%. Our performance was in line with that approved. According to the approved WP 2023, PT NA distributed the funds for E+ over 2 rounds. In KA1, the implementation was 69% in R1 and 31% in R2, and in KA2, in the small partnerships, the implementation was 41% in R1 and 59% in R2. We have assumed the difference between the approved and the implemented. The reasons for this are the number of applications submitted, the number of applications rejected for lack of funds

Concerning the "proportion (%) of first pre-financing payments made within 30 days of the signature of the Grant Agreement (measured on the basis of payments processed during the call year)", the National Agency normally follows the calendar for the management and use of funds for grant support and payments are made within 30 days of the signature of the Grant Agreement by both parties. However, there are some cases where the National Agency is not able to comply with this rule due to the obligation to respect national law, which requires public bodies to make payments only after verifying tax and contribution declarations, certifying that the beneficiaries have no debts to the State and that their situation is regularised. According to internal control tools, the average payment period in 2023 was 13.7 days.

Regarding the indicators "Proportion (%) of final payments processed within 60 days" and "Proportion (%) of final beneficiary reports received on time (during the calendar year)", the NA has a working procedure for final reports which stipulates that the project owner must technically assess the final reports within 45 days for subsequent payment within 60 days. However, the NA acknowledges that these deadlines are generally not met due to difficulties with the IT tools. There are problems with the IT platforms when beneficiaries submit their final reports and there are many others in the analysis process, which means that 11% of beneficiaries submit their final reports on time and the National Agency takes an average of 48 days to make the final payment, due to the obligation to comply with national law, which requires public bodies to make payments only after verifying tax and contribution declarations, certifying that beneficiaries have no debts to the State and that their situation is regularised. According to the internal control too, the average final payments was 6 days. The National Agency acts in accordance with the internal control instruments, with an increased requirement for project owners to monitor beneficiaries, and any deviations found are explained by the platforms. In terms of the percentage of final reports that meet the minimum quality threshold for acceptance without grant reduction (during the calendar year), and in accordance with what is monitored in the quality management system and internal control instruments, the result is 99.6%.

In general, the implementation of primary checks confirmed the correct implementation of the projects, corresponding to the information available at the National Agency and permanently updated by the project officers and the monitoring team.

The desk checks helped the verification after analysing the final reports, consolidating the assessment processes.

The monitoring of the work in 2023 was carried out by the project management teams, with an increase in the execution of mobility and with a lot of commitment from the Organizations and all partners involved, in accordance with the rules.

We had several difficulties in encoding the checks of grant beneficiaries in PMM. Despite many tickets we made on the issues, we still do not have all the checks encoded on the system. Therefore, the primary checks report 2021-23 Erasmus+ and ESC are not accurate and reflect these faults.

Even so we have been able to manage to perform the management of the programmes with quality, compensating the shortage of staff and its high workload with a greater involvement of external experts in the evaluation process and the pool of trainers in information and dissemination activities.

This is being implemented through online and residential activities, single activities, cooperation's, networks and SNACS/LTA projects/activities, with national and transnational scopes and processes, creating a solid and strong basis for the next years, investing time and resources in the preparation of participants, activities, processes and outputs, monitoring progress/results and working on the qualitative follow up, in order to increase and maximise the impact of the Programme and TCA. The activities and processes promoted development of knowledge and competences, exchange of experiences/best practices, increased the quality of projects, both to increase the organizational and pedagogical skills to holder projects and facilitated the process of building and animation of networks and partnerships, increased the competences of participants, newcomer's participation and the reinforcement of cooperation between NA's, fostering by this way, the overall quality of Programme implementation. TCA followed a strategic vision, framed in the overall objectives, priorities and target groups of the E+ aiming to foster youth work quality and support transnational cooperation, in the field of inclusion/diversity, participation and citizenship, democratization, creativity and innovation, employment, entrepreneurship, in order to provide more and equal opportunities for young people and to foster EU values and Youth Goals. Gave also emphasis to the green dimension, mental health/well-being, digital youth work, sports, intercultural dialogue and human rights and gave also focus to the Ukranian situation. Some of the TCA activities have been implemented in synergy with NET, in cases where common topics, focus, objectives and target groups are tackled, maximising resources, impact and outcomes. TCA targeted the practitioners, potential applicants and beneficiaries of the programme, trainers, youth workers, youth leaders, decision makers, staff/representatives of organisations active on the field, stakeholders, multipliers and researchers, with a particular focus on reaching out newcomers and participants with fewer opportunities. The monitor of effective implementation and impact is being held through contribution to RAY projects, several cooperation's, needs collections, reports, tools and activities. The results are used beyond the lifetime of activity, mainly to develop the quality of future activities/partnerships, design strategies, becoming inspiring and creative tools for the development of new ideas and explore possibilities both in learning with mistakes and also in the use of success as an engine for new challenges. The strategy was implemented towards high-level performance, untending to highlight the added value of the participation in the Programme.

In cases where reductions apply, the amount corresponding to the horizontal work package 'Coordination and monitoring' will be recalculated proportionally to the final amount of EU contribution.
